AMENDED NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting **via telephone conference call** pursuant to Texas Government Code, Section 551.125, as amended, and as modified by the temporary suspension of various provisions thereof effective March 16, 2020, by the Governor of Texas in accordance with the Texas Disaster Act of 1975, all as related to the Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas. **The telephone conference call phone number is 1-877-304-9269 and the access code is 608569#.** All members of the public may participate in the meeting via telephone conference call.

The meeting will be held on Wednesday, August 4, 2021, at 1:00 p.m.

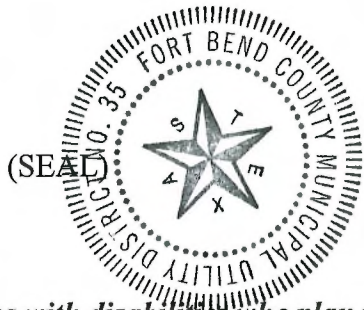
The Board shall consider and/or act on the following matters:

1. Call to order, including explanation of telephone conference call meeting procedures;
2. Comments from the public;
3. Review and approve the minutes of the July 7, 2021, Board of Directors meeting;
4. Review activity reports and/or receive updates regarding Fort Bend County Precinct 3 Constable's Office ("FBCCO");
5. Status of conversion to LED bulbs and painting of the decorative light poles in the community by CenterPoint Energy;
6. Status of installation of warning signs around bodies of water within the District;
7. Consider proposal for wildflower seeding of certain recreational sites within the District;
8. Proposed noise barrier wall to be constructed by TxDOT along State Highway 99 within the boundaries of the District;
9. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
10. Receive the Financial Advisor's recommendation concerning the District's proposed 2021 tax rate, determine intended tax rate, and authorize the:
 - a. Required notice that the Board will consider adoption of a tax rate; and
 - b. Means of providing such notice;
11. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;

12. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
13. Annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution in connection therewith;
14. Engineering Report, including:
 - a. Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of TEC Form 1295;
 - b. Status of construction contracts, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes, including:
 - (i) Repair of approximate 300-foot portion of Little Prong Creek at Fry Road utilizing the SOX erosion repair system and repair of outfall (Double Oak Erosion);
 - c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - d. Consider installation of an emergency generator at the District's remote water well; and
 - e. Status of waste discharge permit renewal applications for Wastewater Treatment Plant Nos. 1 and 2;
15. Report by Champions Hydro-Lawn, Inc., regarding maintenance of drainage facilities, including:
 - a. Proposal for repair and/or rehabilitation of detention pond located at the southwest corner of Gaston Road and Fry Road.
16. Proposal for application of wildflower seeds at certain recreational sites within the District;
17. Storm Water Management Program for the District;
18. Operations and Maintenance Report, including:
 - a. Authorizing the repair and maintenance of District facilities;
 - b. Compliance with Fort Bend County Municipal Utility District No. 34's water supply and waste discharge permits;
 - c. Appeals of District charges;
 - d. Referral of accounts for collection and deeming of various accounts as uncollectible;
 - e. Report regarding water accountability;
 - f. Status of maintenance of the District's park facilities;
 - g. Discussion regarding status of planning Native Plant virtual event;
 - h. Discussion regarding program to reduce the use of flushable wipes within the District; and
 - i. Review report regarding results of Year 2 of 5 Sanitary Sewer Televising and Cleaning Project;
19. Status of implementation of a mass notification system within the District; authorize any

action necessary in connection therewith;

20. Request from Records Management Officer to destroy notes and audio recordings of Board of Directors meetings from February 5, 2020, to April 7, 2021;
21. Attorney's Report, including;
 - a. Discuss requirements of H.B. 1154 and consider options for the District's compliance with same;
22. Convene in Closed Session pursuant to Open Meetings Act, Section 551.071, Texas Government Code, for consultation with the District's attorney regarding pending or threatened litigation or matters protected by attorney-client privilege;
23. Reconvene in Open Session and authorize any action resulting from discussions in Closed Session; and
24. Matters for possible placement on future agendas.
